In case quoted bid amount is in USD, then earnest money calculation should utilize the USD-PKR exchange rate published by SBP the day before the

bid submission date. The earnest money of unsuccessful bidders will be refunded after completion of the bidding process.

3. The successful bidder will be responsible for providing the above-listed items at the designated premises of BMP in Karachi without charging any additional costs.
