Banking Mohtasib Pakistan, Karachi Secretariat (BMP) invites e-applications from the Printers/ Publishers/ Firms registered with the Income Tax and Sales Tax Department for prequalification for the designing and printing of Annual Reports as well as Quarterly Newsletters.

# **INSTRUCTIONS FOR BIDDERS**

### 1. <u>ELIGIBLE BIDDERS</u>

Proposal for pre-qualification is invited from all firms and parties meeting the following requirements.

- 1.1 Vendor must be Karachi based.
- 1.2 Must have a minimum turnover of PKR 30 million per annum for the last three years.
- 1.3 The vendor must be registered with the Income Tax and Sales Tax Department, Government to Pakistan. A valid registration certificate duly verified by the concerned department along with the latest Professional Tax Certificate for the current financial year should be provided.

## 2. EVALUATION CRITERIA

- 2.1 Copies of work orders showing at least 3 years' experience in similar jobs;
- 2.2 Bank Maintenance Certificate and Bank Statement for year 2024-25 showing Cash flow.
- 2.3 Firms will have to provide at least two samples of each following jobs alongwith pre-qualification documents.
  - i. Books;
  - ii. Leaflets;
  - iii. Brochures;
  - iv. Envelopes

The weightage/ Marks for different categories will be followed as per table given below:

Note: Prequalification status shall be decided on the basis of Pass/Fail basis. The applicant must secure at least 40% score in each category and 60% score in aggregate to qualify.

# 3. <u>SUBMISSION OF PROPOSALS</u>

- 3.1. The electronic proposals, prepared in accordance with the instructions in the prequalification documents, must be submitted by using EPADS on or 7<sup>th</sup> March, 2025 at 11:30 a.m.
- 3.2 Manual bids shall not be accepted.
- 3.3 Electronic Proposals will be opened on the same day at 12:00 Noon.
- 3.4 BMP reserves the right to reject the application for Pre-qualification in case of noncompliance of the requirements as stated in the Pre-qualification document, without assigning any reason.
- 3.5 Only pre-qualified bidders will be allowed to participate in procurement.
- 3.5 Framework agreement for a period of one year would be drawn with the qualified bidder whose bid would be considered the most advantageous to carry out the following jobs.
  - Designing and Printing of Annual Report 2024
  - Designing and Printing of three Quarterly Newsletters for the year 2025
